GFCM BUDGET AND MEMBER CONTRIBUTIONS FOR 2011-2012

(Draft)

INTRODUCTION

1. This document provides a breakdown of the main budget chapters for the 2011 and 2012 financial years (Appendix 1) as well as an estimate of forecast expenditures under the autonomous budget (Member contributions) (Appendix 5), according to GFCM Financial Regulations. The document also refers to other incomes deriving from voluntary contributions made by certain Members in support of cooperative projects administered by the Secretariat. As decided by the Commission¹ the budget and Member contributions for the mentioned financial years are presented as a comparative table which points out the variation in individual budget line and in contribution of each Member during the period 2010 to 2012. The technical support that FAO (including regional projects) normally provides to the Commission and continues to provide pursuant to the Agreement establishing the GFCM² is not quantified in terms of budget, as this input is independent of the GFCM autonomous budget and is therefore outside the direct scope of action of the Commission and its Secretariat.

ASSUMPTIONS AND UNCERTAINTIES

- 2. The estimate of all expenditures (global budget) related to GFCM functioning is based on:
 - i) the proposed programme of work of the Scientific Advisory Committee (SAC) and of the Committee on Aquaculture (CAQ) for 2011. It is assumed that the same will apply for 2012 in order to estimate the budget for the following year;
 - ii) an updating of the Secretariat administrative and operational costs;

- iii) the budget needed to cover any new activity proposed by the Commission should be added to this estimate;
- iv) this version of the budget does not include the cost of some requests from subsidiary bodies such as the translation of Task 1 and the SAC glossary in the various working languages of the Commission;
- v) the estimated budget does not include the unforeseen cost that could result from the move to the new Headquarters.

3. As requested by the Commission, the budget of cooperative projects financed from extra budgetary resources and executed by the Secretariat is dealt with separately from the GFCM global budget.

Assumptions

4. The following assumptions, which have budgetary implications, are submitted for consideration by the Commission:

- the budget estimate assumes that the new Secretary will take up his functions on 1 July 2011;
- Members will strive to provide the Secretariat promptly with requested data and ensure support through national experts;
- the Commission will disburse funds to contribute to the move and installation in the new GFCM Headquarters;
- the Secretariat will need to bolster its technical personnel to deal with the increasing volume of work and the new challenges that the Organization will have to face;
- the budget estimate proposed will have to take into account the need to recruit support staff. In the initial phase, a receptionist and a security officer will need to be recruited;
- it is supposed that inflation and the dollar/euro exchange rate will not differ considerably from 2010;
- the need to reorganize the Secretariat³, including any budgetary implications resulting from this process, should be considered in the final version of the budget.
- FAO will maintain its technical support at least at the recent level provided to the Secretariat;

Uncertainties

5. Some uncertainty relates to the implementation of decisions that the Commission might adopt at its Thirty-fifth Session; for example concerning the monitoring of Restricted Fisheries Areas or implementation of the vessel monitoring system or any decision resulting from the sessions of the Committee on Administration and Finance and the Compliance Committee.

7. These uncertainties are not taken into consideration in the draft budget presented. They should first be submitted for review and evaluation by the Commission.

Pending issues

8. FAO Finance has urged GFCM to cover with its autonomous budget a deficit of approximate **US dollars 18,000** most probably derived from costs related to the Twenty-fourth Session of GFCM in Alicante and Twenty-fifth GFCM Session held in Malta. The Commission is invited to take a decision about the payment of the outstanding amount either through the autonomous budget or using the capital funds.

9. FAO Finance has also requested that a higher rate of FAO Servicing costs (at the moment 4,5%) be applied to the new baby projects to be executed by the GFCM Secretariat. The Commission is invited to consider this request and provide guidance on the subject.

GFCM BUDGET FOR 2011 AND 2012

Autonomous budget of the Commission

10. In accordance with the provisions of Article X of the Financial Regulations and the decision taken by the Commission⁴ at its Thirty-second Session, the Secretariat is required to present the draft budget for the next financial year to the Commission for review and adoption, and the budget for the subsequent financial year for review and adoption, subject to possible adjustment at the following session. It is also the Commission's duty to review, adjust and allocate expenditures and determine how the autonomous budget will be structured. The final budget proposal for 2011 and 2012 is the basis for assessment of the contribution of each Member for 2011 and the estimated contribution for 2012.

11. A comparative table of the budget for the period 2010 to 2012 is given in Appendix 1 of this document. Appendixes 2 and 3 provide a provisional breakdown by main budget chapter and line of the Commission's forecast budgets for 2011 and 2012 respectively. Appendix 2 (a) provides details of the estimated cost of official travel. These data are explained at greater length in the explanatory note in Appendix 4. Appendix 5, with a comparative table of contributions for the period 2010 to 2012, shows the calculation of Member contributions for 2011 and 2012, based on the average catch and GDP of each Member for the period 2005-2007 (2010 contribution) and for the period 2006-2008 (2011 contribution), as disaggregated in Appendixes 6 (a, b and c) and 7 (a, b and c), in line with the agreed scheme which is appended to the GFCM Financial Regulations.

12. Taking into account the above, the budget forecasts for 2011 and 2012 support a Secretariat staffed as at the last session in addition to the Fishery Information Manager established by the Commission at its Thirty-third Session. Two consultants were recruited in order to cover, on the one hand, the management of aquaculture information, data of compliance (VMS, port State measures) as well as GFCM web site management and, on the other hand, the scientific editing of GFCM documents, until a possible recruitment of a professional staff (P2) and a general service staff (G6), respectively. It is also strongly desired that the Secretariat be strengthened by recruiting an Expert in Stock Assessment/Population Dynamics at P3 level from October 2011 and the G6 (Scientific Editor) from January 2012. The terms of reference for these two posts, whose importance was highlighted by the Scientific Advisory Committee at its Twelfth Session, held in Montenegro in January 2010, are available in documents CAF:II/2011/Inf.6 and 7. The draft budget also covers the organization of meetings of the Thirteenth Session of SAC and the Seventh Session of CAQ as well as the Thirty-fifth Session of GFCM and related requirements in terms of specialized expertise and qualified consultants for publications and specific studies.

13. On the basis of information and data available to the Secretariat and assuming the Commission approves all proposed expenditures, the total sum of the autonomous budget for 2011 is estimated at **US dollars 1,869,987**, while that for 2012 is estimated at **US dollars 2,335,711**. That represents a 15.15 percent increase in 2011 in relation to the initial budget adopted for 2010 and a 24.91 percent increase in 2012 in relation to the budget proposed for the previous financial year. The proposed increase should allow to equip the Secretariat with the human resources it needs to carry out the Commission's programme of work efficiently and effectively. If the Commission decides to reduce this amount, it will have consequently to reduce its programme of work and therefore reconsider the ambitions.

FAO share of the GFCM global budget

14. Article XI.3 of the GFCM Agreement provides that: "*the expenses of the Commission should be paid out of its autonomous budget, except relating to such staff and facilities as can be made available by FAO*". The expenses to be borne by the Organization are to be determined and paid within the limits of the biennial budget prepared by the Director-General and approved by the Conference of FAO, in accordance with the General Rules and Financial Regulations of the Organization.

Extra budgetary resources

15. The status of the active including financial aspects is described in document CAF:II/2011/2 and the expected activities together with related budgetary incidence is provided below:

European Community Cooperative Project in support of CAQ Working Groups on Aquaculture Sustainability (InDAM Phase 2) and Siting and Carrying Capacity (SHoCMed Phase 2)

16. The remaining amount for SHoCMed project Phase 2 (approximately US dollars 60,332) is expected to be spent during 2011 to cover the consultations for the preparation of the technical document on Allocation Zones on Aquaculture and technical glossary on aquaculture site selection and carrying capacity. In addition, it will cover travels and consultations for the preparation of documents for the workshop on Environmental Quality Standards and on the definition and environmental monitoring within Allowable Zone of Effect of aquaculture activities.

17. Regarding InDAM Phase 2, the first payment of $\notin 68,254.70$ (equivalent to **US dollars 91,372**) will be mainly used to cover travels and consultations for the implementation of the InDAM Pilot case studies Step I in Morocco and Spain and Step II in Tunisia and Turkey; for travels and consultations for the regional meeting of the WGSA on the pilot case studies; and for the dissemination of InDAM results, outputs and documentation which include the preparation of guidelines on the application of indicators.

18. It should be recalled that the contribution from the European Union (DG MARE) cover 50 percent of the activities foreseen for InDAM Phase 2, while the same donor will cover a 30 percent of those planned for SHoCMed Phase 2. Given the provisions of the GFCM Agreement, the national research institutions of the Member Countries are asked to also contribute to the activities of the two mentioned projects, notably by facilitating the involvement of their national experts in related activities.

Italian Cooperative Project in support of GFCM activities: "Strengthening cooperation on fisheries and aquaculture management in the Mediterranean and the Black Sea" (LaMed)

19. With regards to LaMed Component 1, the remaining balance of the first payment received (US dollars 65,755.82) will be used to cover the expenses for consultancies, travels and publications related to the establishment of a regional network of experts on fisheries laws and regulations; the review and analysis of the fisheries regulatory framework in the Mediterranean and the Black Sea; and the updating of the comparative study on the fisheries regulatory framework and the elaboration of a reference publication. This amount will also cover the fees related to the organization on an expert meeting in September 2011.

20. With regards to the LaMed Component 2, the remaining balance of the first payment received (**US dollars 80,150.15**) will be used to cover the expenses for consultancies, travels and publications related to the establishment of a network of experts on Mediterranean coastal lagoons; the preparation of an inventory and review of the interaction between aquaculture and capture fisheries; the preparation of guidelines; the organisation of meetings and workshops and the preparation of case studies and reference publications.

SUGGESTED ACTION FOR THE COMMISSION

21. In the light of the above considerations, the Commission is invited to review the proposed autonomous budget for 2011 and the forecast budget for 2012, taking into account the increase in certain expenditures (inflation) as indicated in the appended explanatory note, and to decide accordingly.

Forecast GFCM autonomous budget for 2012

Explanatory note on the structure of the indicative autonomous budget for 2011 and 2012

An indicative estimate of the GFCM autonomous budget for 2011 and 2012, as suggested in Appendixes 1, 2 and 3, is provided in conformity with Article III.5 of the GFCM Financial Regulations, the Commission's guidelines⁶ and FAO accounting practices. Expenditures are divided into the following main chapters: i) administrative expenditures corresponding to Secretariat staff costs; ii) expenditures relating to the execution of activities, disaggregated into subchapters; and iii) ancillary costs comprising miscellaneous expenditures and FAO servicing costs, set respectively at 1 percent and 4.5 percent of the autonomous budget.

<u>Chapter One</u>: Secretariat staff costs

This chapter covers the salaries and all costs and allowances of Secretariat staff. It includes the monthly gross remuneration of staff, which may be adjusted by the United Nations as a result of costof-living surveys and changes in exchange rate between the US dollar and Euro, as well as other expenses for pension contribution, dependency allowance and health and accident insurance. Some expenses only apply to staff in the Professional category, such as home leave (once every two years) or children's education allowance, while overtime, for example, applies only to staff in the General Service category. The proposed budget envisages all posts already in the 2010 budget with the exception of the posts of Stock Assessment/Population dynamics expert - P3 and Compliance and Aquaculture data manager - P2. For the latter, the proposal is to cover it with the services of a consultant (as until now) to take care of the aquaculture information management and database applications and management of the GFCM website (for 9 months in 2011). This budget proposal also envisages strengthening the Secretariat by recruiting a G6 (Scientific Editor) from 2012, a Security guard/receptionist (G3) and an Office helper (G2) from June 2011. Since Arabic is one of the official working languages of GFCM, the recruitment of an Arabic-speaking Secretary should be envisaged from 2013 to monitor working documents, correspondence and any other task requiring a knowledge of Arabic. This work is currently done under contract. An allocation for overtime and temporary staff (US dollars 35,000 in 2011 and US dollars 20,000 in 2012), drawn up on the basis of actual expenditures in 2010, has been retained under this budget line.

Chapter Two: Activities

Consultants. The proposal is to maintain this budget item at US dollars 60,000 in 2011, including 9 months of contract (**US dollars 16,200**) to secure the services of web administration/processing of fisheries, aquaculture and applications data as well as consultancy contracts to facilitate implementation of selected SAC and CAQ activities and to coordinate the joint stock assessment sessions of the two working groups on demersal species and small pelagics (in the case where the post of a Stock Assessment expert is not established in the Secretariat). In 2012 this item could be revised downwards (**US dollars 30,000**) if the Commission decides to establish the related P2 post.

Duty travel. This chapter covers the duty travel (tickets and *per diem*) of Secretariat staff and non-staff consultants, experts and specialists. The table in Appendix 2(a) provides an estimate of duty travel envisaged in 2011 which is maintained at the same level as 2010 (**US dollars 165,000**). This amount covers the Secretariat's participation in selected meetings, the pre-selection meeting of the Selection Panel for the appointment of the Executive Secretary and the interview of the short-listed candidates for the above mentioned post together with participation in selected meetings of partner organizations. Participation in non-GFCM meetings allows the Secretariat to exchange information, enhance

cooperation and coordination with other regional fisheries bodies and maintain contact with authorities in charge of managing the fisheries sector. The travel requirements under this budget item are reported in the relevant table (Appendix 2(a)). It should be noted that this budget line will need to be strengthened should the Commission decide to systematically cover other travel expenses such as those of the two vice-chairpersons (at the rate of 2 meetings per year).

Chargeback. This subchapter covers interpretation costs (travel and *per diem* excluded) in four languages for the Thirteenth Session of the SAC (five days), the Seventh Session of the CAQ and the Thirty-fifth Session of the GFCM, including the sessions of the Compliance Committee (CoC) and the Committee on Administration and Finance (CAF). It should be noted that an increase in interpretation and translation costs could be envisaged from 2012. This subchapter also covers the procurement of books, the cost of producing meeting documents, official translation in the three languages of the Commission and dispatch of official correspondence.

Training. The proposal is to raise the allocation to **US dollars 12,000** and **US dollars 15,000** for 2011 and 2012 respectively, in order to cover training for the staff of the Secretariat as well as certain training activities on stock assessment/SAC and to contribute, on request, to the CIHEAM/IAMZ courses or seminars on progress in aquaculture.

Equipment. The forecast of **US dollars 20,000** for 2011 and **US dollars 30,000** for 2012 will serve to cover the cost of expendables and non-expendables taking in consideration the specific needs for the new premises.

Operating costs and overheads. These subchapters cover general costs, including the rental cost of two servers, the cost of support services for the organization of meetings of subsidiary bodies of the SAC and the CAQ, contingencies, including costs for dispatch by DHL, if required, and other minor communication expenses (mobile phone and website) and related services (cleaning, etc). The suggestion is to allocate a lump sum of **US dollars 30,000** for this line for 2011 and **US dollars 20,000** for 2012.

Contracts (*including scientific publications*). This budget line essentially covers all expenditures relating to publications and associated activities such as editing, printing of official reports, printing and translation of scientific publications and technical reports of subsidiary bodies of the Committees, in addition to finalization of Arabic versions of working documents and the report of the Commission's annual session. The cost related to the recruitment of a film making specialist for the production of a film which will outline the work of GFCM and its interaction with its constituency is also included in this budget line. The proposal is to allocate the amount of **US dollars 30,000** for 2011 and **US dollars 20,000** for 2012.

Performance review. This budget item, which amounts to **US dollars 5,000**, covers the final expenditures related to the evaluation of GFCM performance, including (when applicable) the travel cost of one of the expert panel to participate in the Thirteenth Session of SAC, the Seventh Session of CAQ and the Thirty-fifth Session of the GFCM to present the outcome of this review.

Interpreters' travel. This chapter, for a total of **US dollars 15,000**, covers the duty travel (tickets and *per diem*) of the interpreters who worked in the Thirteenth Session of SAC, held in Marseille in February 2011. This is considerably less than the allocated amount in 2010, due to the fact that the Seventh Session of CAQ and the Thirty-fifth Session of GFCM have been scheduled at FAO Headquarters. For 2012, an amount of **US dollars 40,000** is dedicated to this budget line.

Office move.: This subchapter, which amounts to **US dollars 20,000** is meant to contribute in covering some expenses resulting from the move to the GFCM new Headquarters, planned to take place in June 2011. No amount is proposed for 2012.

Chapter 3: Miscellaneous expenditures and FAO administrative support costs

The first budget line relates mainly to ancillary costs (including hospitality). It is suggested that this be kept at 1 percent of the total autonomous budget. In accordance with Article III.5 of the GFCM

Financial Regulations, FAO administrative support costs are calculated at 4.5 percent of total envisaged costs for 2010 and 2011.

As a result of the above, the sums of **US dollars 1,869,987.00** and **US dollars 2,335,711.00** have been earmarked for 2011 and 2012, respectively, to cover salaries and associated costs.
