# REPORT OF THE SECRETARIAT ON ADMINISTRATIVE AND FINANCIAL ISSUES

#### INTRODUCTION

1. The aim of this document, including its Appendixes, is to report on administrative and financial actions taken during the 2011 intersessional period. It includes issues such as staffing, the GFCM Task Force process, GFCM new headquarters, meetings, publications, the status of ratification of the GFCM Agreement as amended in 1997, the status of payment of the contributions made by Members to the autonomous budget and reviews of the statement of the expenditures made in 2011 including for extrabudgetary baby projects.

#### **ADMINISTRATIVE ISSUES**

#### Recommendations adopted under Article V of the GFCM Agreement

- 2. The Secretariat officially transmitted to Members and Observers the text of recommendations and resolutions adopted at the Thirty-fifth Session of the Commission (Rome, May 2011). These were also posted on the GFCM website. Upon completion of a "grace" period following notification of the recommendations, during which no official objection was lodged, and in accordance with Article V of the GFCM Agreement, the above mentioned recommendations entered into force on 28 September 2011. The Members were duly informed.
- 3. The Members were also reminded of a number of commitments agreed by the Commission, including the submission of national reports on the implementation of GFCM decisions<sup>1</sup>, the Combined Vessel Record, authorizations for remotely operated vehicles (ROVs) in the research of Red Coral, list of vessels presumably having exerted illegal unreported and unregulated (IUU) fishing and the list of ports designated for inspections, dolphin fish fisheries and Task 1. The status of communication of information by Members is reproduced in document COC:VI/2012/2 "Status of implementation of GFCM decisions by Members".

## Achievements within the remit of the Task Force for modernizing and improving the legal and institutional framework of the GFCM

- 4. The activities of the Task force, established at the thirty-fifth session of the GFCM, commenced at the end of September 2011. Firstly, an online Discussion Forum, consistent with the terms of reference of the Task Force, was created to give the possibility to Members to express their views on key topics as singled out in said terms of reference. To this end, a questionnaire was uploaded on the Discussion Forum in order to further elaborate upon identified issues. Subsequently, an expert meeting was organised (Rome, December 2011) to gather proposals for the improvement of the SAC and CAQ. The other two subsidiary bodies, the COC and CAF, were reviewed in a comparative study made by a consultant.
- 5. To address the specificites of the GFCM sub-areas, a set of four sub-regional meetings was organized. These meetings were held in Rabat, Morocco, for Central and Western Mediterranean (February 2012), in Beirut, Lebanon, for Eastern Mediterranean (March 2012), in Bucharest, Romania, for the Black Sea (March 2012) and in Bar, Montenegro, for the Adriatic (April 2012). During these meetings, it was possible to discuss, directly with concerned Members from the relevant sub-regions, those issues singled out by the Task Force in view of the possible amendment of the GFCM Agreement and associated rules.
- 6. Finally, the outcomes emerged from the expert sub-regional meetings and from the analysis of the replies to the questionnaire are scheduled to be analysed and validated during the final meeting of the Task Force with Members' representatives (10-11 May 2012, Marrakech, Morocco). This meeting is also open to the observers and partner Organizations to ensure a participative and transparent process. The meeting will recommend to the Commission at its thirty-sixth session the course of action to follow in relation to its improvement and modernization.
- 7. It should be recalled and underlined that the implementation of the above mentioned activities was possible thanks to the financial support of the Italian Ministry of Agriculture, Food and Forestry Policies (MiPAAF).

#### Specific actions of GFCM for the Black Sea

- 8. In conformity with the decision of GFCM to increase the activities of the Commission relating to the Black Sea, the first meeting of the GFCM ad hoc Working Group on the Black Sea was held in Costanta, Romania, last January. Several actions of significant importance were identified by this meeting and will be submitted to the consideration of the Commission at its 36th Session. To further the work that was done in Costanta, the Working Group on the Black Sea will meet again during the next inter-Sessional period.
- 9. During the intersessional period several contacts occurred between the GFCM Secretariat and the three Black Sea riparian States in particular with those which are not currently Members of the Commission. In particular, the GFCM Secretariat liaised with the Russian Federation whose representatives were received in the GFCM HQs. Acting on the request of competent authorities of Russian Federation, the GFCM Agreement was translated into Russian and transmitted accordingly in order to be examined at national level. There is hence an ongoing process relating to the possible adhesion of Russian Federation to the GFCM. Furthermore, in various occasions meetings held by GFCM were attended by Black Sea riparian States, including non Members of the GFCM, and the encouraging progress made by the Commission in playing its role of the international organization established to address issues relating to fisheries and aquaculture in the Black Sea was acknowledged with satisfaction by GFCM Members.

10. It has to be underlined that at the very moment of writing the GFCM Secretariat is in contact with the services of the FAO with a view of being abreast of potential developments concerning the future expectations of the Organization on the management of Black Sea fisheries and aquaculture. The Commission will be timely informed on the outcomes of this process.

#### Functioning of the Secretariat

Organization of the Secretariat and appointment of staff

- 11. Mr. Abdellah Srour was formally elected Executive Secretary of the Commission during the Thirty-Fifth Session of the Commission held in May 2011. Following his appointment, it was decided to freeze the post of Deputy Executive Secretary for 2012. A decision still to be taken for the coming years.
- 12. In 2011, the Secretariat saw the recruitment of the Data Compliance Officer (Professional Category P-2), Mr Federico De Rossi (Italian citizen), starting from October 2011, who is now, *inter alia*, in charge of the management and quality of statistical data, as well as the restructuring and maintainance of the GFCM website and data flow management.
- 13. The post of Bio-statistician (shifted to P-4 Fishery Resources Officer) was left vacant in August 2011. Following the departure of Mr Matthew Camilleri, recruited in GFCM Secretariat in 2007, his former duties have been covered by other staff members. A vacancy announcement for the Fishery Resources Officer (P4) was issued from 3 November 2011 to 14 December 2011 and resulted in the selection of Miguel Bernal (Spanish national), who will take up his duties on 1 July 2012.
- 14. The post of administrative assistant (G-3), left vacant in December 2010, was filled by Ms Florence Dickens (British citizen) who joined the GFCM Secretariat in November 2011.
- 15. A vacancy announcement for the post of Scientific Editor/Translator (P-2) agreed at the Thirty-fifth Session was issued and at the time of printing this document, the recruitment was being finalized.
- 16. With the move to the new headquarters, in order to comply with FAO Security rules and as advised by FAO Chief of Security, the tasks of the Security Guard (Position G2) was accomplished on temporary basis by Mr Abdallah Ben Hamida (Tunisian citizen) and Mr Gianni Alessio (Italian citizen) according to a established working hours (7.30 am to 7 pm, divided in 2 shifts). The Office helper (G3) suggested to be created starting from June 2011 during the Thirty-fifth Session remained vacant and it is suggested to cover it on temporary basis considering the specific nature of this job.
- 17. As already pointed out during the Thirty-fourth and Thirty-fifth Sessions, strengthening the Secretariat in terms of administrative and technical staff has become an urgent need to cope with the increasing and more demanding volume of work.

It should be noted that, in order to face the workload, selected tasks were carried out with the contribution of temporary human resources (e.g. volunteers, interns and consultants) who collaborated in addressing issues like VMS, selected species of elasmobranches, stock assessment, etc.

#### GFCM intersessional meetings and other meetings at which the Secretariat was represented

18. The Secretariat coordinated and actively contributed to the preparation and delivery of the 28 meetings agreed by the Commission, including 15 meetings of subsidiary bodies and the annual Session of the Scientific Advisory Committee (SAC), 7 meetings of subsidiary bodies of the Committee on Aquaculture (CAQ). In addition, GFCM held 6 meetings related to the Task Force established during the Thirty-fifth session to modernize and improve its legal framework and organised several meetings with partner organisations and selected GFCM Members and non-GFCM Members to enhance collaboration. The Secretariat also participated in a number of external meetings of partner organizations or entities and selected meetings of FAO regional projects. At some of those meetings, the Commission was represented by its Chair or Vice-Chair or by the chairperson of the Committees. Because of time and budget constraints, the Secretariat was again obliged to decline invitations to several other meetings relevant to the work of the Commission. Lists of the above meetings are provided in Appendix 1 of this document.

#### **Publications**

19. During the intersessional period, the Secretariat produced 35 technical and administrative documents: 22 "grey literature" documents available on the GFCM website, 7 already published and 6 to be released in 2012. The list of publications is provided in Appendix 2.

#### Other issues

- 20. Several other tasks coordinated directly by the Secretariat are not detailed here. These include liaison and communication with Heads of Delegation and focal points, strengthening of cooperation with partner organizations, in particular through the drafting of Memoranda of Understanding with selected organizations, coordinating the editing, translation and distribution of documents and organizing the technical preparation of SAC and CAQ activities.
- 21. The following aspects should however be noted:
  - Bureau of the Commission: during the intersessional period, liaison was maintained at an excellent level of coordination and consultation with the Bureau of GFCM and the Bureau of its committees. A meeting of GFCM Bureau was held in September 2011 to review major issues, including the workplan implementation and Task Force set up.
  - Collaboration with key partners: the collaboration was strengthened in areas of common interest with GFCM partners, such as the International Commission for the Conservation of Atlantic Tunas (ICCAT), the International Union for Conservation of Nature (IUCN), the UNEP Regional Activity Centre for Specially Protected Areas (RAC/SPA) and the International Centre for Advanced Mediterranean Agronomic Studies (CIHEAM). In particular, the Secretariat drafted Memoranda of Understanding with the Agreement on the Conservation of Cetaceans of the Black Sea, Mediterranean Sea and contiguous Atlantic Area (ACCOBAMS), the Commission on the Protection of the Black Sea Against Pollution (Black Sea Commission BSC), EUROFISH, the International Council for the Exploration of the Sea (ICES), MedPAN, the Mediterranean Regional Advisory Council (RAC-MED), and the Mediterranean Action Plan for the United Nations Environment Programme (UNEP-MAP) to be possibly adopted and signed during the thirty-sixth session.
  - Information tools: standard forms and methodologies were prepared, improved and posted on-line to facilitate the presentation of results of fishery stock assessments to specialized working groups, the preparation of reports by Members, including the Task 1 statistical matrix and table, the vessel records, and to reconcile the FAO STATLANT 37A catch

reporting scheme with geographical sub-areas. The SIPAM information system continued to be developed. In addition, the data collection for red coral is being put in place.

#### Issues related to the move and management of GFCM new HQ and its budgetary implications

22. The GFCM Secretariat settled down in its offices located in Palazzo Blumenstihl, at Via Vittoria Colonna 1, on 7<sup>th</sup> September 2011. The move to its new HQs required a considerable effort made mainly by FAO Corporate Services, Security and GFCM Secretariat to cover all logistical and technical arrangements. The management of the new premises has proved to be challenging due to the adjustments needed to the new environment along with various maintenance works and arrangements with the condominium.

#### Status of acceptance of the 1997 amendments to the GFCM Agreement

23. So far, 21 Members have deposited their instruments of acceptance (Appendix 3). Members that have not yet done so are Egypt (remitting its contribution) and Israel. Regarding the case of the Syrian Arab Republic, the Secretariat received a letter on 17 September 2010 from the Syrian Embassy in Rome notifying that Syria ratified the agreement on 12 July 2009. According to FAO Legal Office, this Letter could not be considered as a formal ratification since the specific standard model for the ratification process had not been used. The Syrian Embassy was informed accordingly.

#### FINANCIAL MATTERS

- 24. In May 2011, the Commission adopted a global budget for 2011 amounting to **US dollars 1,708,240.00** as autonomous budget. A "call for funds letter" was sent on 25 May 2011 through diplomatic channels and directly to GFCM Heads of Delegation.
- 25. The sum of contributions received in 2011 amounted to **US dollars 1,513,781.76** (88.61 % of the adopted budget), as shown in Appendix 4. The amount of **US dollars 163,537.49** was also received as partial outstanding contribution of Italy, Malta, Romania, Slovenia and Tunisia for the previous year (total received in 2011 amounted to **US dollars 1,677,319.25**). Thus, the status of the 2011 contributions can be summarized as follows:
  - twenty Members have deposited their instruments of acceptance and remitted their contributions;
  - one Member (the Syrian Arab Republic) has neither yet deposited the formal instruments of acceptance nor remitted its contribution;
  - three Members (Greece, Libya and Monaco) have deposited their instruments of acceptance but have not paid their contribution;
  - one Member (Israel) has neither deposited its instrument of acceptance (nor participated in the vote for the selection of Executive Secretary), nor paid its contribution.
- 26. Appendix 4 shows a negative balance for Greece (US dollars 93,047), , Libya (US dollars 43,555.84), Malta (US dollars 91), Monaco (US dollars 77,767), Montenegro (US dollars 2,865.82) and Syrian Arab Republic (US dollars 61,005) probably in some cases, for not having taken bank transfer charges into account. The contribution received from Italy exceeded the amount due by US dollars 1,672.20 while the contribution from Tunisia by US dollars 198.70.

#### Payment and use of arrears

It should be recalled that: i) Regulation IV.3 states that "any unliquidated prior year obligation shall be cancelled or, where an obligation remains a valid charge, transferred against current appropriations"; ii) Regulation V.1 states that "pending receipt of annual contributions, the Secretary is authorized to finance budgeted expenditures from the uncommitted balance of the autonomous budget"; iii) Regulation V.3 also stipulates that "as of 1 January of the following calendar year, the unpaid balance of such contributions shall be considered to be one year in arrears"; iv) at its Thirtieth Session, the Commission agreed to use arrears to constitute a Working Capital Fund to serve as a buffer for the Secretariat in the case of delays in the remittance of contributions; v) at its Thirty-first Session, the Commission authorized the Secretary to readjust activities and expenditures as required for meeting ongoing obligations at the end of 2007, using arrears if necessary<sup>2</sup>; vii) at its Thirty-second Session<sup>3</sup>, the Commission had asked the Secretariat to adjust the budget to include, among other matters, Arabic as a working language for the Session.

#### Arrears

As shown in Appendix 4, the balance of accumulated pending contributions<sup>4</sup> for the 2005, 28. 2006, 2007, 2008, 2009, 2010 and 2011 GFCM fiscal years amounted to US dollars 276,460.76 as of 31 December 2011. The increase over the previous year is essentially due to the failure of Greece, Libya, Monaco and the Syrian Arab Republic to pay their contributions and/or arrears in full.

### **Working Capital Fund**

In view of the above and based on data provided directly by the FAO central accounting system (under Oracle), the GFCM received -from 2005 and accountable for 31 December 2011- a total of US dollars 8,279,019 <sup>5</sup> in contributions, for a total of expenditures of US dollars 8,120,652<sup>6</sup>. The Working Capital Fund (i.e. the contingency fund of arrears remitted since 2005) accountable for 31 December 2011 amounted to US dollars 291,700. It is worth noting that such amount is very low to cover the expenses of the Secretariat until the new budget is approved. It is, therefore, recalled that Members should submit their contributions within 30 days after the budget approval, and also ensure to pay their arrears, if applicable, as a matter of priority.

#### Budgetary expenditures under the autonomous budget in 2011

- 30. The 2011 accounts continued to be kept by the FAO central accounting system (based on Oracle), coupled with the Secretariat's budget monitoring system which tracks allocations, forecasts, obligations and expenditures of each chapter.
- Table 1 below provides an overview of the financial status of the autonomous budget, i.e. total expenditures as of 31 December 2011, and showing a negative balance between income vs. adopted budget (US dollars 30,921), but a positive balance in budget based on income vs. expenditures (amounting US dollars 27,423) as well as in adopted budget vs expenditures (totalling US dollars 58,344).

32. The financial status of the main budget chapters is given in Appendix 5 following standard FAO/Oracle trust fund budget line allocations. They can be divided into three broad categories: i) salaries of Secretariat staff (about 60% of total expenditures); ii) activities (about 34% of total expenditures); iii) miscellaneous expenses (1%) and FAO service costs (4.5%), which are a predetermined percentage of the autonomous budget. The expenditures effected under each budget chapter and corresponding budget lines are explained in greater detail in the explanatory note on budget expenditures provided in Appendix 6.

#### Status of GFCM extra-budgetary resources

33. At its Thirty-first Session, the Commission requested that extra-budgetary resources (i.e. voluntary contributions from Members) also be reflected in the financial statement. The situation is as follows:

#### Recently closed activities

European Commission Cooperative Project in support of CAQ Working Groups on Aquaculture Sustainability (InDAM Phase 2) and Siting and Carrying Capacity (SHoCMed Phase 2)

- 34. An agreement between DG MARE and GFCM was signed on 24 September 2010 to launch SHoCMed Phase 2 with a contribution of €60,938.79 (approximately **US dollars 85,138.75**) representing 30% of the project eligible costs. The GFCM received a first payment of € 48,751.03 (**US dollars 68,111**).
- 35. An agreement between DG MARE and GFCM was signed on 16 November 2010 to launch InDAM Phase 2 with a contribution of € 85,318.37 (approximatively **US dollars 114,214.98**), representing 50% of the project eligible costs. The GFCM received a first payment of €68,254.70 (**US dollars 91,372**).

#### Recently launched activities

- 36. An agreement between DG MARE and GFCM was signed on 26 October 2011 to launch a project on the "Implementation of a Vessel Monitoring System (VMS) in the GFCM area" with a contribution of €120,000 (approximately US dollars 164,159) representing about 90% of the project eligible costs. The GFCM received a first payment of €96,000 (US dollars 131,327), of which the amount of approximately US dollars 45,937 was spent in 2011 for a workshop on the implementation of VMS in the Mediterranean and Black Sea, held in Zagreb, Croatia, from 28 to 30 November 2011. Both counterparts signed an Amendment to the Agreement on 8 March 2012 in order to further work on the project until 31 October 2012.
- 37. An agreement between DG MARE and GFCM was signed on 28 October 2011 to launch a project on "Stock assessment of selected species of Elasmobranchs in the GFCM area" with a contribution of € 70,000.37 (approximately **US dollars 95,760**) representing 90% of the project eligible costs. The GFCM received a first payment of €50,400.26 (**US dollars 68,947**), of which the amount of approximately **US dollars 51,197** was spent for a workshop on Stock Assessment of selected species of Elasmobranchs, held in Brussels, Belgium, from 12 to 16 December 2011. Both counterparts signed an Amendment to the Agreement on 13 March 2012 in order to further work on the project until 31 October 2012.

Italian Cooperative Project in support of GFCM activities: "Strengthening cooperation on fisheries and aquaculture management in the Mediterranean and the Black Sea" (LaMed)

38. The project on "Strengthening cooperation on fisheries and aquaculture management in the Mediterranean and the Black Sea" (LaMed), funded by the Italian Ministry of Agriculture, Food and Forestry Policies (MiPAAF) with a total contribution of €300,000, was launched on 1 September 2010. The project has two components: Component 1 "Fisheries laws and regulations in the Mediterranean and the Black Sea (LaMed-1)" and Component 2 "Mediterranean coastal lagoons management: interactions between aquaculture and capture fisheries (LaMed -2)". The amount of US dollars 182,678 was spent in 2011 in various expert meetings convened during the year.

Italian Cooperative Project in support of GFCM activities: "Supporting Task Force activities for the improvement and modernization of the General Fisheries Commission for the Mediterranean"

39. The project on "Supporting Task Force activities for the improvement and modernization of the General Fisheries Commission for the Mediterranean" is aimed at assisting the Commission in the identification of the necessary improvements to be brought to the GFCM Agreement and associated procedural and financial Rules and was launched in December 2011 with a total contribution of € 135,000 (US dollars 184,678) from the Italian Ministry of Agriculture, Food and Forestry Policies (MiPAAF). The amount of US dollars 39,286 was spent in 2011 for the organisation of a technical expert meeting to address relevant issues in the framework of the main Committees of the GFCM.

Italian Cooperative Project in support of GFCM activities: "Information System for the promotion of aquaculture in the Mediterranean" (SIPAM)

40. The project on "Information System for the promotion of aquaculture in the Mediterranean" funded by the Italian Ministry of Agriculture, Food and Forestry Policies (MiPAAF) with a total contribution of € 30,000 (US dollars 41,039) was launched on 12 October 2011. The organisation of the Thirteenth Session of SIPAM and related preparatory activities, initially scheduled for November 2011, were postponed due to technical reasons to February 2012.

#### Extra-budgetary contributions from FAO and Italy towards running expenses of GFCM HQ

41. It is recalled that FAO Director-General had approved that FAO contribute on a voluntary basis € 46,000 per annum (US dollars 62,500) to cover specific running costs (water, electricity, etc.) while the host country, Italy, would contribute € 100,000 per annum, corresponding to the remaining share of the estimated total of these costs. In this respect, GFCM received a contribution of US dollars 115,920 (corresponding to 2010 and 2011) from FAO and a contribution from the Italian government for the amount of € 100,000 (about US dollars 133,333) for 2011, of which the amount of US dollars 80,250 was spent. Such contributions served to complete the purchase of furniture and equipment for the new offices, to cover start-up and maintenance works as well as running costs for a total amount of US dollars 196,170 (e.g. condominium, cleaning, maintenance and start up works, water and electricity supplies, wi-fi coverage, etc).

#### SUGGESTED ACTION FOR THE COMMISSION

42. The Commission is invited to review the administrative report and provide general guidance, particularly on issues relating to the strengthening of personnel in relation to the autonomous budget and, in doing so, to assess the remittance of contributions by Members, with a special focus on the situation and use of arrears, and on the financial statement of the autonomous budget in 2011.

#### Explanatory note on budget expenditures per chapter

Below are explanations on the payment of expenditures by chapter, based on incomes recorded for 2011, i.e. contributions paid by Members (income-based budget). This is the budget adopted at the Thirty-fifth Session, as adjusted to incorporate amendments decided by the Commission and application of the allocation factor for each budget line, as shown in Appendix 5. The financial operations and status by chapter are based on Appendix 5, which presents incomes and expenditures following the FAO/Oracle standard budget line allocation. Total expenditures comprise payments until 31 December 2011, including expenditures related to the organization of the Fourteenth Session of SAC, held in Marseille, Seventh Session of CAQ held at FAO HQ and Thirty-fifth Session of GFCM, also held at FAO HQ. Other expenditures (e.g. salaries and expenditures) committed from January 2012 are not accounted for, as they apply to the 2012 fiscal year.

#### **Chapter 1: Administration**

This chapter covers salaries and remuneration of the Secretariat staff, including certain overhead costs and allowances (e.g. basic medical plan, pension scheme, dependant's allowance, etc.) and is subject to fluctuations (positive or negative) in post-adjustment (cost of living in Rome), which is difficult to fully anticipate in the forecast budget. In addition, when adjusting the original (adopted) budget to the income-based (real) budget, the budget lines for staff salaries remain constant as related expenditures are incompressible.

*Professional staff.* The first sub-chapter includes expenditures for the five staff in the professional and higher categories (Executive Secretary, Aquaculture Officer, Biostatistician, Fishery Information Officer and Data Compliance Officer<sup>13</sup>). In relation to the adopted budget (see Appendix 5), the salary expenditures for the professional staff produced a positive balance, which was mainly imputable to the departure of the Biostatistician in July 2011 and the late appointment of the Data Compliance Officer.

Administrative staff. The sub-chapter covers expenditures for Secretariat staff in the General Service category (amount forecast for a programmer/systems analyst, administrative clerk and administrative/financial assistant). The budget line was not fully used given that the post of administrative assistant (G3) left vacant in December 2010, was filled in November 2011.

The allocations for temporary staff and overtime, which resulted in the negative balance, were mainly used on temporary staff (from the Temporary Assistance Pool), interns and overtime. These resources were needed to support the administrative and logistic activities related to the preparation of statutory meetings (Sub-committees and Coordinating meetings of SAC, Thirteenth Session of SAC, the Seventh Session of CAQ and the Thirty-fifth Session of GFCM), as well as in administrative tasks.

#### **Chapter 2**: Activities

Consultants: This sub-chapter, which resulted in a positive balance of **US dollars 975**, covers the fees of consultants, i.e. contracted specialists (project formulation, statistical data quality, GFCM database management and development, GFCM website maintenance, etc.), moderators and resource experts for meetings.

*Travel*: This sub-chapter covers all travel (tickets and daily subsistence allowances) of the GFCM Bureau, Secretariat staff, Coordinators, interpreters, consultants, selected national experts and resource persons recruited for technical meetings of the SAC and CAQ subsidiary bodies, the Thirteenth Session of SAC, the Seventh Session of CAQ and Thirty-fifth Session of GFCM. Total expenditures for this budget line were slightly positive (US dollars 852).

Chargeback: This budget line covers costs for interpreters (excluding travel and per diem) serving the Thirteenth Session of SAC, the Seventh Session of CAQ and the Thirty-fifth Session of GFCM, translation and internal printing of Session documents. It also covers official translation and mailing of official correspondence (e.g. call for funds letters, letters of invitation to statutory meetings, GFCM circular letters, etc.), as indicated above. The negative balance (US dollars 63,875) is attributable to the revised (higher) rates of interpreters for the biennium 2010-2011 as well as to the fact that two statutory meetings were held at FAO HQ, where the honorarium of interpreters is higher.

*Training*: Language and IT training of Secretariat staff scheduled for 2011 started successfully in the course of the year with individual and class lessons. The balance for this budget line resulted in the positive amount of **US dollars7,209**.

Equipment: This sub-chapter comprises budget lines for the procurement of expendables and non-expendables. Expenditures included the purchase of various items (e.g. flags and country name plates) for meetings, special software packages and development libraries for data analysis and presentation purposes as well as computers and laptops. The balance of this sub-chapter results in a positive amount of **US dollars 4,069**.

General operating costs, overheads and miscellaneous expenses: These sub-chapters cover respectively running costs (electricity, cleaning of premises, heating, etc.), operation and maintenance of equipment and security services, if any. Virtually all these expenditures continued to be covered by FAO until the Secretariat moved to its new HQ on 7 September 2011. Only expenditures such as telephone bills (mobile phones only) were charged to the autonomous budget. Overheads include support costs for the organization of meetings of SAC subsidiary bodies and contingencies, including the dispatch by DHL of meeting documents (SAC and GFCM Annual Sessions). These sub-chapters also include the hiring of two servers to host certain GFCM computer applications and databases. The balance of this sub-chapter is negative for the amount of **US dollars 1,639**.

Contracts (including scientific publications). All expenditures related to preparation of publications, printing of official reports, editing in Arabic of scientific publications (e.g. GFCM Studies and Reviews Series), preparation of meeting documents and published technical reports of the subsidiary bodies of the Committees and the Commission are charged to this budget line. The temporary appointment of a scientific editor and the costs related to the illustration and layout of the publication on the 60<sup>th</sup> Anniversary of GFCM are also included. Reference is made to the list of publications in Appendix 2. This sub-chapter posted a positive balance of **US dollars 2,604**.

Office move: This budget line, which covers expenses related to relocation, purchase of selected security and miscellaneous appliances, contract with suppliers for works at Palazzo Blumenstihl, etc, presented a positive balance of **US dollars 1,160**.

As reflected in the Balance (expenditures vs adopted budget) of Appendix 5, it could be concluded that the over expenditure in **Activities** (for a total of **US dollars -48,644**) was compensated by savings in **Administration** for the amount of **US dollars 94,068** 

#### **Chapter 3: FAO support costs**

*Miscellaneous*: This budget line (1% of total available budget), used for hospitality and miscellaneous expenses produced a positive balance of **US dollars 10,407**.

FAO Servicing Costs: FAO support costs were calculated before closure of the accounts at 4.5% of the original budget for 2011, in accordance with GFCM Financial Regulation III.5, and resulted in a positive balance of **US dollars 2,513**.

Finally, it should be noted that the "balance" column of Appendix 5 should be read as "before budget revision" (i.e. compensation between positive and negative budget lines), as the purpose of this presentation is to highlight budget lines whose initial allocation was insufficient and thus indicate where increases might be considered in the draft budget proposal for 2012 (document CAF:III/2012/3).
