3. Report of the SIPAM activities carried out since the 11th Session

Participants will be informed on the activities carried out since the eleventh annual session of SIPAM (9 – 10 December 2009; Trabzon, Turkey). (by the Secretariat)

- The integration of the activities of the CAQ Working Groups into the SIPAM IS. (Portals related to the databases and information systems supporting the Working Group on Aquaculture Marketing, Working Group on Siting and Carrying Capacity and Working Group on Sustainability of Aquaculture)
- *Updated reporting facilities national summaries and customised reports*

The main production pattern on the Mediterranean and Black Sea marine and brackish aquaculture production, based on FAO statistics as well as on SIPAM available data, will be presented.

5. Submission of aquaculture data and information (Rec. GFCM/33/2009/4)

Discussion and presentations will be focused on:

- 5.1 The status of data collection and data submission by each country in accordance with the requirements of the GFCM Recommendation GFCM/33/2009/04 on the reporting of aquaculture data and information through the SIPAM IS (by National Coordinators).
- 5.2 Difficulties encountered and improvements in the data entry, submission and reporting processes. (by National Coordinators).
- 5.3 Issues related to the definition and statistical reference of certain parameters (eg. capture based species, statistical area, value etc.) (by participants)

6. Marketing data scheme and marketing data collection for Mediterranean aquaculture data collection

The conclusions and proposals of the WGMA – SIPAM joint meeting on the marketing data scheme and marketing data collection will be presented and reviewed by the meeting. Focus will be given to the data synergy between the WGMA and SIPAM. (by participants)

7. Production Centre and aquaculture statistics

Discussion will focus on how to implement a data collection scheme for Production Centre on the basis of the proposed amendments to the Recommendation GFCM/33/2009/04 as proposed by the CAQ workshop on data harmonization and adopted by SIPAM (by participants).

A presentation will be also be delivered on the aquaculture data collected by EUROSTAT, especially in relation to data on aquaculture facilities and related production centres in line with the recent EU regulation (regulation EC 762 (2008)). (by Eurostat)

A presentation will be made on the development within the framework of CWP^1 -Aquaculture (by FAO)
