THE BLACK SEA



The longest shoreline among all the other littoral states of the Blacksea

Representing 42% of all maritime jurisdiction area of the Blacksea

Almost 80 % of Turkey's fisheries revenues are generated from the Blacksea fishing activities.

FISHERIES INFORMATION SYSTEM (FIS)

Registry of commercial fishing vessels,

Registry of recreational fishers,

Issue of special fishing permits to fishers,

Monitoring of Atlantic Bluefin tuna quotas,

Monitoring of venus clam quotas,

Monitoring of eel quotas,

Collection of biologic data,

Monitoring of anchovy catches transshipped to cold storages or processing plants

Issue of catch certificate under the scope of EU Regulation 1005/2008,

Inspection forms,

Collection of fisheries and aquaculture statistics.

VESSEL MONITORING SYSTEMS

Vessels over 15 metres are under an obligation to record and keep logbook

Automated Identification System (AIS)

Obligatory for all fishing vessels over 15 m.

Vessel Monitoring System (VMS)

Obligatory for BFT (Bluefin Tuna) vessels.

SPECIAL REGULATION FOR TURBOT

No fishing activity for turbot shall be permitted from 15 April to 15 June

The minimum landing size for turbot shall be 45 cm total length

The minimum legal mesh size for nets used to catch turbot shall be 400 mm

SPECIAL REGULATION FOR ANCHOVY

No fishing activity for anchovy shall be permitted from 15 April to 31 August

The minimum landing size for anchovy shall be 9 cm total length

Only 16.00-08.00 hours are permitted for fishing during open season

SPECIAL REGULATION FOR BABY CLAM

All methods of baby clam harvesting with any gears are prohibited between 1st May - 31st August

All methods of baby clam harvesting are prohibited in waters shallower than 5m.

Special annual quota scheme determined by the MOFAL for the baby clam, monitored via Fisheries Information System (FIS)

SPECIAL REGULATION FOR SHARK AND DOLPHIN

For all season, shark and dolphin catching are prohibited in the Black Sea and other coastal lines of Turkey





FISHERIES CONTROLS

Controls are done during

- License issuance,
- Fishing operations,
- Landings after fishing operations,
- Transportation of products and
- Points of sale.

ENFORCEMENT

Sanctions are being applied for fisheries violations

- Fines,
- Confiscation of products caught,
- Temporary seizure of fishing license and
- Cancellation of fishing license.
