# GFCM BUDGET AND MEMBERS CONTRIBUTIONS FOR 2014 - 2016

#### INTRODUCTION

1. In line with GFCM financial rules, the foregoing report provides the proposed GFCM Autonomous Budget based on a new approach covering financial years 2014 to 2016 (Appendix 1 refers), as well as a forecast of contributions for the same period to be charged against its Members (Appendix 3 - Member Contributions). Information is also given on voluntary contributions made by donors, in support of selected strategic activities within the GFCM Framework Programme (FWP) and currently administered by the Secretariat. The support that FAO – through various services and its regional projects – has provided to the Commission so far pursuant to the Agreement establishing the GFCM<sup>1</sup> is not quantified in this report.

#### **ASSUMPTIONS AND UNCERTAINTIES**

## Assumptions

- 2. The following assumptions, which have budgetary implications, are submitted for the consideration of the Commission:
  - Members will strive to provide the Secretariat promptly with requested data and ensure support through national experts and national focal points;
  - The Secretariat will need to bolster its technical personnel to deal with the increasing volume of work and the new challenges that the Organization will have to face;
  - It is expected that inflation and the dollar/euro exchange rate will not differ considerably from 2013;
  - FAO and its regional projects will maintain their support to the Commission and its subsidiary bodies, at least at the recent level provided;
  - Extra-budgetary funds will be sought to finance the costs of the IT cloud-services which have effectively served as an integrated platform for meetings and information management, data submission on stock assessment, technical activities and communication with GFCM stakeholders;
  - The host country (Italy) will maintain its financial support to cover part of the running expenses of the Secretariat, as it has done since the move of the Secretariat to Palazzo

- Blumenstihl, and FAO will continue to contribute Euro 46,000 per annum for the same purposes;
- Travel of vice-chairs of the Commission and its subsidiary bodies is not foreseen unless they represent the relative chair (for a maximum of two travels per year);
- GFCM core activities and ad-hoc projects will carry on being exempted from the payment of 8 percent Improved Cost Recovery Uplift (ICRU) imposed to FAO Projects.

#### **Uncertainties**

3. Some uncertainties remain regarding the implementation of decisions that the Commission might adopt at its thirty-eighth session (e.g. the organisation of activities in connection with multiannual management plans and red coral, the implementation of the Data Collection Reference Framework as well as initiatives linked to small-scale fisheries and the aquaculture multi-stakeholder platform or any decision resulting from the sessions of the Committee on Administration and Finance and the Compliance Committee). These uncertainties are not taken into consideration in the draft budget presented.

## Pending issues

4. As shown in Appendix 3 of document CAF:V/2014/2, the government of Serbia has an outstanding amount of US dollars 8,785.42, which refers to the contribution prior its withdrawal from the GFCM. The Commission is invited to consider the possibility of writing off this outstanding amount from its accounting books.

#### **GFCM BUDGET FOR 2014-2016**

Triennial approach to budget proposal

- 5. The proposed budget for 2014-2016 takes into consideration the request made by the Commission at its third Extraordinary Session (Athens, April 2014), to calculate GFCM budget in Euro following a new, mid-term, triennial timeframe from 2014. The new approach is based on:
  - i) an estimate of the Secretariat administrative and operational costs;
  - ii) the need to adopt a different perspective in budget formulation in order to secure the financial resources for the smooth functioning of the Commission, thus avoiding any shortcomings deriving from, *inter alia*, exchange rate fluctuations affecting salaries and overall operating expenses.
- 6. The new budget proposal will imply the following:
  - i) for 2014, contributions from GFCM Members will continue to be paid after 30 days of budget endorsement. From 2015, contributions will be expected as of 1<sup>st</sup> January 2015 until one month after the annual session (as a maximum time-limit). At the thirty-ninth session in 2015, the 2016–2017 budget will be adopted along with an indicative budget for 2018. The same approach will follow in the future;
  - ii) the triennial budget will be discussed in Euro and contributions will be subsequently converted in US dollars. Call-for-funds will thus be kept in US dollars and contributions continue to be paid in US dollars on a twelve-month basis;
  - iii) each year the Secretariat will formulate a three-year proposal for the Commission, with a firm budget for the first two years and a tentative budget for the third year, to be finalized or readjusted the following year taking into consideration the yearly workplan of the Commission and its subsidiary bodies;

- iv) the yearly work plan of GFCM activities will be proposed, discussed and endorsed during each annual session. Any other strategic, ad-hoc activities to be carried out with extrabudgetary funds will fall within the framework of discussions held during each annual session and will need the endorsement of GFCM Members;
- v) the redefinition of the Budget Headings will be gradually aligned with FAO standards. It is proposed that the three main pillars of GFCM budget be Staff, Functioning and Strategic Activities;
- vi) the budget needed to cover any new activity proposed by the Commission should be added to the proposed totals.
- 7. As requested by the Commission, the budget of cooperative projects financed from extrabudgetary resources and executed by the Secretariat, including the activities of the GFCM Framework Programme (FWP), is dealt with separately from GFCM autonomous budget.

#### **Autonomous budget of the Commission**

- 8. The budget for the period 2014-2016 is provided in Appendix 1 of this document. The data are explained at greater length in the explanatory note in Appendix 2. Appendix 3, featuring a comparative table of contributions for the period 2014-2016, shows the calculation of Members contributions for 2014, 2015 and 2016, based on the average catch and GDP of each Member for the period 2009-2011 (2014 contribution), period 2010-2012 (2015 contribution) and period 2011-2013 (2016 contribution), as disaggregated in Appendixes 4 (a, b and c), 5 (a, b and c) and 6 (a, b and c), in line with the agreed scheme which is appended to the GFCM Financial Regulations.
- 9. Taking into account the above, the budget proposed for 2014-2015 and the forecast for 2016 supports a Secretariat staffed as shown in table A of Appendix 1. A temporary assistant was recruited for four months in February 2014 to replace the GFCM Administrative Assistant (G-3) on leave-without-pay; this latter position may become vacant in June 2014 and, in such case, a vacancy announcement for a similar post at G-3/G-4 level (on the basis of needed requirements) will be advertised. In 2014, it is foreseen that technical experts to work on activities such as small-scale fisheries and data collection, as well as the finalization of publications and specific studies, will be recruited on consultancy contracts together with a Liaison consultant to manage communication with GFCM Members, partner organisations and stakeholders. The hiring of the Security Guard (G-2) will remain pending in 2014 while the recruitment of a Liaison Officer is foreseen in November 2015 (2 months). The budget proposed also covers the organization of GFCM statutory meetings.
- 10. On the basis of the information and data available to the Secretariat and assuming the Commission approves all proposed expenditures, the total sum of the autonomous budget is estimated at **Euro 1,632,073** for 2014, **Euro 1,686,936** for 2015 and **Euro 1,757,145** for 2016<sup>2</sup>. The totals indicated would represent a 3.36 percent increase in 2015 in relation to the budget for 2014 and a 4.16 percent increase in 2016 in relation to the budget proposed for the previous financial year.

# Extra budgetary resources

11. The status of the active projects, including their financial aspects, is described in document CAF:IV/2014/2 and the expected activities together with related budgetary incidence for 2014 are provided below:

### European Commission Cooperative Projects in support of GFCM activities

- "Supporting the work of the Task Force in view of: A) strengthening data collection and submission frameworks for fisheries management purposes in the GFCM area of competence and B) promoting the implementation of the GFCM Guidelines for multiannual management plans"
- 12. The activities relating to this project 90% donor-funded were concluded in March 2014. The total expenditure for 2014 amounted to **US dollars 25,994**. In the first months of 2014, and until its conclusion, the project focused on the preparation of technical material related to Black Sea fisheries, with the collaboration of recruited consultants.
  - "Further support to the work of the Task Force in view of: A) strengthening data collection and submission frameworks for fisheries management purposes in the GFCM area of competence and B) promoting the implementation of the GFCM Guidelines for multiannual management plans"
- 13. This project 90% donor-funded ended in April 2014. Since the beginning of the year to its conclusion, a total amount of **US dollars 20,156** was allocated to finance the organisation of the Sub-regional Group on Stock Assessment in the Black Sea (SGSABS) and the dedicated workshop to test the feasibility of implementing multiannual management plans in the Black Sea.
  - "Improving the status of Mediterranean and Black Sea fisheries through better data collection, management and enforcement"
- 14. Since the beginning of the year, this project has focused on the preparation of workshops on i) the management of red coral and ii) marine protected areas in the Mediterranean and Black Sea. The project has also focused on the requirements needed for the implementation of the GFCM Data Collection Reference Framework (DCRF), carried out in consultation with the SAC and its subsidiary bodies. Furthermore, a workshop on harmonizing scientific surveys in the Black Sea and follow-up workshops on IUU and management plans along with a workshop on elasmobranchs are also planned for 2014. The preparation of the first GFCM Report on the status of Mediterranean and Black Sea Fisheries (to be released by mid-2015) will be another substantive initiative in 2014. Some consultants will be recruited to collaborate in the completion of mentioned activities.

Cooperative Projects in support of CAQ Working Groups on Aquaculture Sustainability (InDAM Phase 3) and Siting and Carrying Capacity (SHoCMed Phase 3)

- 15. SHoCMed Year 3, which commenced in November 2012, was concluded in January 2014. In 2014, a total of **US dollars 1,649** was spent on the completion of a harmonised environmental monitoring scheme for marine aquaculture activities. The narrative and financial reports are underway.
- 16. InDAM Year 3, commenced in November 2012, similarly ended in January 2014. The narrative and financial reports will be sent to the donor in the coming weeks. The amount of **US dollars 22,273** was spent on a meeting on "indicators for sustainable aquaculture and its application" (held in Morocco) and on the follow-up work on regional indicators and their reference points.

## <u>Multidonor Project in support of GFCM activities for the improvement and modernization of the</u> General Fisheries Commission for the Mediterranean (GFCM Task Force/Framework Programme)

17. In the context of the FWP, the Commission benefited from the contribution of several of its Members. For instance, the amount of **US dollars 18,000** was received from Turkey to cover interpretation and logistic related costs in connection with the meeting of the Task Force Working Group on the amendment of the GFCM legal framework, held in Istanbul in February 2014. A contribution of **Euro 15,000** was received from the government of Spain and another contribution for an equal amount from the same donor is expected in the coming weeks. Additional grants from Italy, France and Monaco towards the FWP are expected in the course of the year. The activities organized in the framework of the Task Force/FWP included: a) workshops on stock assessment and feasibility

tests to implement the GFCM Guidelines for management plans; b) a workshop on red coral management in the Mediterranean; c) a workshop on Marine Protected Areas in the Mediterranean and Black Sea; d) the GFCM Extraordinary Session for the amendment of the GFCM Agreement; and e) the preparatory phase of the joint GFCM-Italian Ministry of Environment project on environmental status of marine population (MedSuit), described below. The development of these activities included the participation of staff from the Secretariat, consultants as well as cooperation with GFCM Members and third parties. The technical work and methodology used in these activities have been endorsed by the SAC.

The Italian Ministry of Environment/GFCM Mediterranean cooperation for the sustainable use of the marine biological resources (MedSUIT)

18. MedSuit, an 18 month-project, is gathering information on good environmental status for exploited marine populations in the Mediterranean, in light of the Marine Strategy Directive Framework and of the EcAp process. In this context, a number of activities have been already carried out since the beginning of 2014, which include, *inter alia*, consultancies, participation in meetings relating to both the Marine Strategy Directive Framework and the EcAp process and coordination with relevant organizations (e.g. UNEP-MAP and ICES). The creation of a portal on SharePoint dedicated to this initiative is underway. In the second part of 2014, an inception meeting is expected to take place.

Extra-budgetary contributions from FAO and Italy towards running expenses of GFCM HQ

19. FAO will continue to contribute on a voluntary basis **US dollars 62,500** for 2014 to cover specific running costs (water, electricity, cleaning, premises insurance etc.) together with Italy, which will also contribute  $\in$  100,000 per annum for the same purpose.

#### SUGGESTED ACTION FOR THE COMMISSION

20. In light of the above considerations, the Commission is invited to review the proposed autonomous budget for 2014 and 2015 along with the forecast budget for 2016, taking into account the increase in certain necessary expenditures as indicated in the appended explanatory note and to decide accordingly.

#### **APPENDIX 2**

#### Explanatory note on the structure of the proposed autonomous triennial budget for 2014-2016

A proposal for 2014-2016 GFCM autonomous triennial budget, as suggested in Appendices 1, 2 and 3, is provided in conformity with Article 11 of the GFCM draft amended Agreement, the Commission's guidelines<sup>3</sup> and FAO accounting practices. Expenditures – to be gradually aligned under FAO Budget Headings – are divided into the following main chapters: i) Secretariat staff; ii) Functioning (expenditures relating to the execution of activities of the Commission), disaggregated into subchapters; iii) ancillary costs comprising hospitality and miscellaneous expenditures as well as FAO servicing costs, set respectively at 1 percent and 4.5 percent of the autonomous budget and iv) extra-budgetary funded Strategic Activities under the GFCM/FWP.

#### **Chapter One:** Secretariat staff

This chapter covers the salaries and all costs and allowances of Secretariat staff. It includes the monthly gross remuneration of staff, which may be adjusted by the United Nations as a result of cost-of-living surveys and changes in exchange rate between the US dollar and Euro, as well as other expenses for pension contribution, dependency allowance and health and accident insurance. Some expenses only apply to staff in the Professional category, such as Home Leave (once every two years) or Dependants' Education Allowance, while Overtime, for example, applies only to staff in the General Service category. The proposed budget envisages the possible recruitment, in 2014, of an Administrative Assistant (at G-3/G-4 level) in case this post remains vacant (the person appointed for this position is on extended leave-without-pay) as well as the recruitment of a Liaison Officer in 2015 (2 months).

#### **Chapter Two:** Functioning

Temporary Human Resource: An allocation for temporary staff and Overtime (**US dollars 70,000** in 2014 and **US dollars 80,000** in 2015-2016), drawn up on the basis of actual expenditures in 2013 and Secretariat's actual needs (slight increased rates of retirees covering Security in 2014 and replacement of the Administrative Assistant on leave-without-pay for 4 months).

Consultants: The proposal is to set this budget item at **US dollars 27,500** for the triennial period 2014-2016 to cover the cost of the experts on small-scale fisheries and data collection as well as the Liaison consultant, along with the work of the translator/editor for the finalization of Arabic versions of working documents and the report of the Commission's annual session.

Duty travel: This chapter covers the duty travel (tickets and per diem) of Secretariat staff and non-staff consultants, experts and specialists, for an amount of **US dollars 90,000** in 2014 and **US dollars 85,000** annually in 2015-2016. The proposed amounts cover the Secretariat's participation in GFCM activities and selected meetings of partner organizations. Participation in non-GFCM meetings allows the Secretariat to exchange information, enhance cooperation and coordination with other regional fisheries bodies and maintain contact with relevant authorities operating in the fisheries sector.

*Training:* The proposal is to keep the allocation to **US dollars 5,000** per annum throughout the triennial period to be used for the training the Secretariat staff and training activities related to the Commission.

*Expendable procurement:* This budget heading — meant to cover the expenses deriving from the purchase of expendable goods (e.g. meeting materials, software, nameplates, etc.) and the printing of GFCM reports and publications — forecasts **US dollars 12,500** annually for 2014-2016.

*Non-expendable procurement:* An allocation of **US dollars 6,000** per year for the triennium is being proposed towards the purchase of such goods, which includes equipment (computers, laptops, etc.).

General Operating Expenses: This subchapter covers general costs, including the rental cost of a server, the cost of support services for the organization of meetings of subsidiary bodies of the SAC and the CAQ, contingencies, etc. The suggestion is to allocate a lump sum of **US dollars 29,000** for 2014 and **US dollars 25,000** per year for 2015-2016.

Internal / External Services (Chargeback): This subchapter covers interpretation costs of GFCM statutory meetings in four languages (travel and per diem excluded), including the sessions of the Compliance Committee (CoC) and the Committee on Administration and Finance (CAF) for the amounts of US dollars 175,000 for 2014 and US dollars 165,000 yearly for 2015-2016. This subchapter also covers the cost of printing of meeting documents, as well as their translation into the three official working languages of the Commission, costs for dispatch by mail, pouch and DHL, if required, other minor communication expenses (mobile phones and fax bills) and related services, transportation costs, stationery, and other.

*Task Force/Framework Programme:* This budget item, which amounts to **US dollars 25,000** for 2014 and **US dollars 50,000** annually for 2015-2016, covers the expenditures related to the activities in the remit of the Task Force for the modernisation of the Commission and the GFCM First Framework Programme.

*Interpreters' travel:* This chapter allocates **US dollars 25,000** per year during the period 2014-2016, to cover the duty travel (tickets and *per diem*) of the interpreters serving GFCM statutory meetings.

#### Chapter 3: Hospitality and Miscellaneous, FAO administrative support costs

The first budget line mainly relates to ancillary costs (including hospitality and miscellaneous expenses). It is suggested that this be kept at 1 percent of the total autonomous budget, resulting in US dollars 21,270 for 2014, US dollars 21,985 for 2015 and US dollars 22,900 for 2016. In accordance with Article III.5 of the GFCM Financial Regulations, FAO administrative support costs are calculated at 4.5 percent of total envisaged costs. As a result of the above, the amount of US dollars 96,672, US dollars 99,922 and US dollars 104,081 have been earmarked for 2014, 2014 and 2016, respectively.

#### **Chapter 4: Strategic Activities (funded through voluntary contributions)**
