




1. Setting conservation priorities areas: A review of six existing conservation initiatives









Main results and conclusions

- Multiple spatial conservation plans have been developed in recent years.
- Gaps in conservation and management planning, particularly within the southern and eastern regions and for offshore and deep sea habitats.
- Ten areas, encompassing 10% of the Mediterranean Sea, are consistently identified among the existing proposals, with an additional 10% selected by at least five proposals.
- These areas represent top priorities for immediate conservation action.
- · Major challenges:
 - 1. the need for spatial prioritization,
 - 2. acquisition of additional information from data-poor areas, species or habitats, and
 - 3. establishment of transboundary governance and collaboration in socially, culturally and politically complex conditions.
- Collective prioritised action is needed for the north, western, and high seas, while developing initial information-based plans for the south and eastern is urgent.
