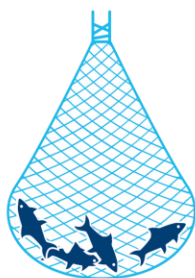

Mid-term strategy (2017-2020) towards the sustainability of **FISHERIES**



1. Reverse the declining trend of fish stocks

- Strengthened scientific advice
- Multiannual management plans
- Assessed socio-economic impacts



2. Support livelihoods for sustainable small-scale fisheries

- Livelihood diversification, market access and decent working conditions
- Participatory mechanisms
- Profitable fisheries



3. Curb illegal, unreported and unregulated (IUU) fishing

- Modular monitoring, control and surveillance
- Regional standards for vessel monitoring and control practices
- Reinforced inspections



4. Minimize and mitigate unwanted interactions

- Focus on climate change, marine litter and non-indigenous species
- Enhanced gear selectivity
- Spatial management measures



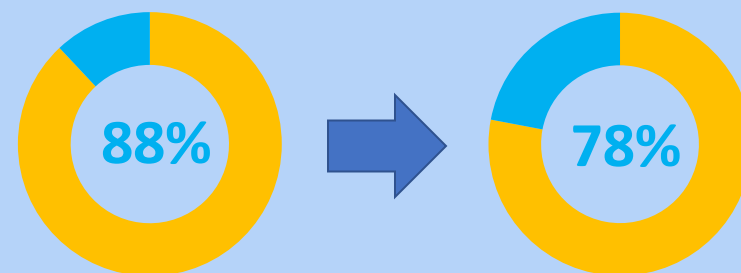
5. Enhance capacity building and cooperation

- Science-policy interface
- Synergies with relevant international organizations
- Training and technical assistance

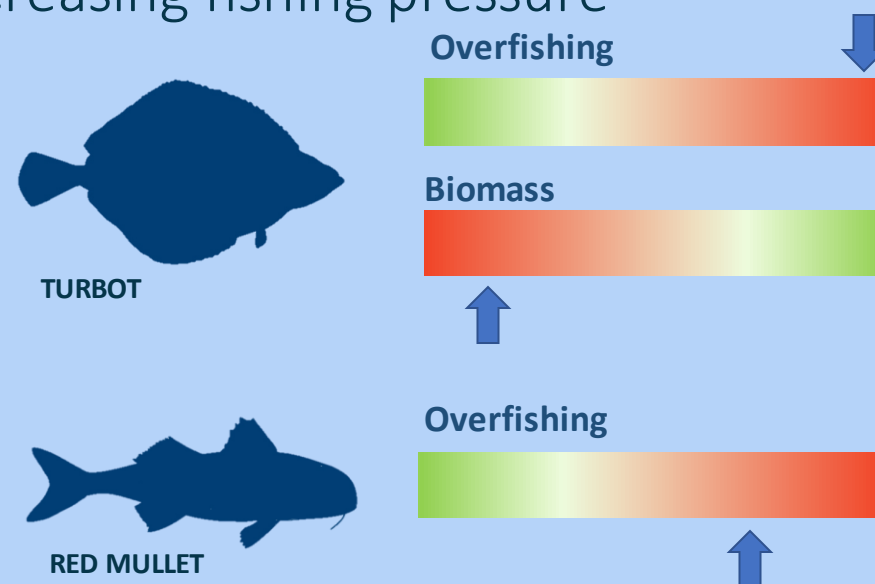
MAIN ACHIEVEMENTS: Science and management

- **10 management plans** adopted
- **9 fisheries restricted areas** implemented
- Data improved through 4 scientific **surveys-at-sea**
- Large-scale **research programmes** and a discard monitoring programme to enhance knowledge
- **Science-policy interface** boosted through the Forum on Fisheries Science

Reduction of 10% in overexploitation since 2014



Decreasing fishing pressure



MAIN ACHIEVEMENTS: Socio-economic dimension

- 10-year (2018-2028) **Regional Plan of Action for Small-Scale Fisheries (RPOA-SSF)** adopted as a political commitment toward the long-term sustainability of SSF
- Awareness raised on the contribution of fisheries to **social development** and **livelihoods** through:
 - More accurate and comprehensive socio-economic data
 - Improved information on the role of social protection

MAIN ACHIEVEMENTS: Compliance and enforcement

- Adoption of a **Regional Plan of Action to Fight against IUU Fishing (RPOA-IUU)**

- Proclamation of the **International Day in the Fight Against IUU Fishing** as an official UN observance
- Best practices in fighting IUU fishing awarded

TARGET 1: BUILD AN EFFICIENT REGULATORY AND ADMINISTRATIVE FRAMEWORK TO SECURE SUSTAINABLE AQUACULTURE DEVELOPMENT



TARGET 2: ENHANCE INTERACTIONS BETWEEN AQUACULTURE AND THE ENVIRONMENT WHILE ENSURING ANIMAL HEALTH AND WELFARE



TARGET 3: FACILITATE MARKET-ORIENTED AQUACULTURE AND ENHANCE PUBLIC PERCEPTION

MAIN ACHIEVEMENTS: Aquaculture

- Capacity-building and knowledge sharing promoted through **Aquaculture Demonstrative Centres**
 - Implementation of **dedicated zones for aquaculture**
 - **Market-oriented production and social acceptability** promoted
 - Environmental services of aquaculture highlighted
- Collaboration between producer organizations strengthened





A modern Commission constantly adapting to emerging priorities in the region

- Enhanced subregional approach
- Improved cooperation with stakeholders, including civil society (17 MoUs)
- Strategic activities promoted through specific projects from extrabudgetary funds
- Flexibility to adapt to changing circumstances, including the COVID-19 pandemic

Support the socio-economic dimension of the fisheries and aquaculture sectors,
including through robust value chains



Improve conservation of the marine environment, including interactions with
fisheries and adaptation to climate change impacts



Promote innovation, scientific research, technology transfer and capacity building,
including through broader partnerships and stakeholder engagement

3 Nov 2020

Online high-level meeting

- Brainstorm on pressing priorities for the fisheries and aquaculture sectors

1st quarter 2021

Wide consultation and online coordination meeting

- Consultations with a wide array of stakeholders to gather inputs
- Consolidate inputs and develop a zero draft of the new GFCM strategy

June 2021 (Greece)

High-level meeting on the new strategy

- Adoption of the new GFCM strategy

Nov 2021 (Albania)

44th session of the GFCM

- Adoption of a multiannual workplan for the implementation of the new strategy and the identification of funding sources
